<b>WATER DEPOSIT</b>	<p><b><u>This Agreement</u></b> is between the Town of River Falls, Alabama, a corporation and existing under and by virtue of the Laws of the STATE OF ALABAMA, hereinafter called the "Corporation", and the undersigned water user, hereinafter called the "Water User".</p> <p><b><u>Witnessed</u></b>, that, whereas the water user desires to purchase Domestic, Commercial, Agricultural, Industrial, or others uses, from the Corporation, ad to enter a water user's agreement, as required by the By-Laws of the corporation.</p> <p><b><u>Now, Therefore</u></b>, in consideration of the mutual covenants, promises and agreements herein contained, it is hereby understood and agreed.</p>

- 1.** The Water User will make application for service at the Office of the Town of River Falls, at the same time pay the connection fee and make the necessary meter deposit as provided in the rate schedule. A Health Department approval for septic permit is required BEFORE SERVICE WILL BE ESTABLISHED. \_\_\_\_\_ (Initials)
- 2.** A cash security deposit of \$25.00 (home owners), \$50.00 (renter) or \$100.00 (commercial) will be required of all customers. No part of deposit will be refunded until all fees are paid or deducted from deposit. It is the sole responsibility of the Water User to update current address and or phone number with the River Falls Water System, any Water User who does not provide accurate or current information to the River Falls Water System within thirty (30) days shall forfeit the deposit in whole or any remainder thereof. Prices are subject to change.
- 3.** To upgrade a new or existing connection, each customer, subscribing to the service of the Corporation, shall pay a connection fee (installation fee) of \$900.00 short side and \$1,200.00 long side plus costs.
- 4.** The Corporation shall furnish, subject to the limitations as provided for in the by-laws, service rules and regulations; hereinafter provided for, such quantity of water, as the Water User may require in connection only with this occupancy of property, located at River Falls, Alabama.
- 5.** The Water User shall install and maintain at owner's expense, a service line which shall begin, at a point designated by the Corporation, and his legal property line, and extended to the dwelling and other portions of the premises.
- 6.** The Water User's service line shall connect to the distribution system of the Corporation, at the place designated by the Cooperation, and provided the Corporation has determined in advanced that the water system is of sufficient capacity to permit delivery of water to that point.
- 7.** The Water User shall pay for such water, at such rates, time and place, as shall be determined by the Corporation.
- 8.** The Corporation shall install a cut-off valve and a water meter in each service. Such as, the cut-off valve shall be installed either off the Water User's premises, or upon the Water User's premises, within three (3) feet of the property line. The corporation shall have exclusive right to use cut-off valve and water meter, to turn it on and off.
- 9.** The Corporation shall make the final determination, in any question of location of any service line connection, to its distribution system, and shall determine the allocation of water to the Water Users in the event of water shortage.
- 10.** The Corporation may shut off the Water Users who allows a connection or extension to be made to his service Line for the purpose of supplying water to another user. Any violator shall pay a penalty fee of no less than \$250.00 and no more than \$500.00 EACH WATER USERS IS REQURIED TO HAVE HIS OWN METER. \_\_\_\_\_ (Initials)
- 11.** Water bills are due payment in full by the 10<sup>th</sup> day of each month. The failure of a Water User to pay water charges, duly imposed, shall result in the automatic imposition of the following penalties:
  - A.** Nonpayment within five days of the due date will be subject to a penalty of \$5.00 in addition to original charges.
  - B.** Water meters are read on the 20<sup>th</sup> of each month, or the next business day, in case of weekends or holidays. If the total bill amount is not paid in full, by the meter reading day, your water meter will be locked. \_\_\_\_\_ (Initials)
- 12.** In the event it becomes necessary, for the corporation to shut off the water from a Water User's property, for violation of the rules and regulations, a fee of \$50.00 for the first time, or \$75.00 for each time thereafter, will be charged for re-connection of services, and the deposit will be applied to the water bill. A new Deposit will be required along with the total amount due before services will be resumed. A default contract will be signed with information of further penalties.



**13. Other Fees:**

- Account Transfer Fee**.... \$25.00

**14.** Payment of services is extended at the time service is rendered. Partial payments- A contract will be required on all partial payment of arrangements. Failure to fulfill the contract will result in termination of service.

**This forgoing**, not withstanding, thee Corporation reserves the right to make or amend the By-Laws or the rules and regulations of the Corporation from time to time, and the Water User agrees to abide by such changes upon notice thereof.

The Water Users understands that the refundable meter deposit of \$25, \$50, or \$100.00 shall be applicable to any unpaid balance owed by the User, the Corporation for services rendered. It is the sole responsibility of the User to give the Corporation a valid address (maximum of 30 days) Otherwise your entire deposit will be forfeited. All refundable deposit shall be issued after final billing at the end of the month.
